# SUBMISSION OF ARTICLES FOR PROFESSIONAL SCIENTIFIC PUBLICATIONS OF IVAN KOZHEDUB KHARKIV NATIONAL AIR FORCE UNIVERSITY

The manuscript volume should be at least 4 full pages in Ukrainian, English or Russian.

Page size: A4 (21 × 29.7 cm).

Page setup margins: left - 2.25 cm; right - 2.25 cm; top - 2 cm; bottom - 2.5 cm.

Body text use Times New Roman font; face - Roman; font size - 10 pt, Line spacing is set by multiplier of 1.1.

Formulas use the following settings for MS Equation.

It is necessary to present the manuscript in electronic form, which is presented according to the requirements and with printed copy, signed by all authors.

#### Structure of the manuscript

The article should include the following elements:

- general problem statement and its relation to up-to-date scientific and practical tasks;
- analysis of recent research and publications in the relevant field;
- statement of the article tasks; the main part explaining the research conducted and obtained scientific
  results:
- conclusions of the conducted research and prospects of development in the future works.

## Abstract of the manuscript

Abstract of manuscript should be written in Ukrainian, English and Russian, and include not less than 6 lines and explanation:

- subject matter, topic and objective of the research;
- method (methods) or methodology of research;
- results of research;
- possible applications of research results.

#### Reference list

The reference list should include not less than 12 sources for the past 10 years that have been published. Herewith not less than 50 percent of sources should be from foreign journals. Self-citation of the authors in the list of references should not exceed 15 percent.

If the basic language of the article is Ukrainian or Russian, then two reference lists should be completed:

- the first one (reference list in original language) according to the State Standards of Ukraine (ДСТУ) 8302:2015 "Bibliographic references: general statements and compilation rules";
- the second one should be in English and in Latin (transliteration) "References" according to the Harvard British Standards Institution.

If the reference has digital object identifier DOI, then it should be given at the end of the description, for example https://doi.org/10.30748/nitps.2017.29.17.

#### Information about the authors should contain:

- scientific degree, academic title, full name;
- position, affiliation;
- ORCID ID:
- e-mail.

# Requirements for the authors:

- ensure that results of research contained in the manuscript compose independent and original work;
- submit the original manuscript, that has not been published in other journals and publications;
- provide reliable results of the conducted research;
- recognize the contribution of all persons who influenced the research or helped to define the nature of the scientific work presented in the article;
- in case of using the work fragments by other's or borrowing other author's materials, the authors are required to provide complete bibliographic references with the obligatory indication of the author and primary source. Submitted materials will not be returned to the author.

## **External peer-reviewing**

External peer-reviewing is conducted purposely for critical evaluation of manuscripts that are published by authors who are not the members of editorial staff. Editorial staff forwards published research articles to the external review which is underway anonymous both for authors and reviewers.
